



VA Education Benefits Overview

900,000 Vets Used GI Bill Benefits Nationwide in 2019


Only 41% of MA Vets & NG/R

Reported using VA/State Education Benefits through 2017

Chapter 33 → Post 9/11 GI Bill

GENERAL REQUIREMENTS

- Served at least 90 days of total Active Duty (after 9/10/2001), or
- Discharged with a service-connected disability after 30 days, and
- MUST have an honorable discharge

Expiration Guidelines

- Separated before $1/1/13 \rightarrow 15$ Years
- Separated after 1/1/13 → No Expiration



Chapter 33 → Post 9/11 GI Bill

SERVICE REQUIREMENTS

Member Serves	% of Maximum Benefit Payable
At least 36 months	100%
At least 30 continuous AD* and was discharged with a SC** disability	100%
At least 30 months, but less than 36 months	90%
At least 24 months, but less than 30 months	80%
At least 18 months, but less than 24 months	70%
At least 6 months, but less than 18 months	60%
At least 90 days, but less than 6 months	50%
*AD = Active Duty **SC = Service-Co	nnected

Tuition and Fees Payments – Institutions of Higher Learning

Type of School	Max. Tuition/Fee per Academic Year
Public	All Tuition/Fee per year for an in-State Student
Private or Foreign	Up to \$25,162.14 per year (national Maximum)

Books and Supplies Stipend

\$1,000 Yearly Book Stipend (\$41.66 per Credit Hour)

Example:

Fall 2021 Semester – 12 Credit Hours

- 12 Hours * \$41.66 = \$500 Payment (\$500 Remain)
 Winter 2021 Semester 3 Credit Hours
- 3 Hours * \$41.66 = \$124.98 Payment (\$375.02 Remain)
 Spring 2022 Semester 12 Credit Hours
- 12 Hours * \$41.66 = \$500 Payment \$375.02 Payment (\$0 Remain)
 Summer 2022 Semester 6 Credit Hours
- 6 Hours * \$41.66 = \$250 Payment **\$0 Payment** (\$0 Remain)

Local Rates for 100% Eligible

- Boston \rightarrow \$3,024 per month
- Worcester \rightarrow \$1,878 per month
- Springfield \rightarrow \$1,683
- Bridgewater \rightarrow \$2,295
- Fitchburg \rightarrow \$2,115

MHA Example

School \rightarrow UMass Boston: \$3,024 Max MHA Benefit TIS* \rightarrow 30 months: 90% VA Education Benefit eligibility Enrollment Level \rightarrow 9 Credits (3 Classes): 3/4 or 75% enrollment

• Rounded to the nearest tenth = 80%

How to Calculate \rightarrow

• \$3,024 MHA * 90% Eligibility * 80% Enrollment = **\$2,177.28 per month**

MHA Rates for Online Learning

Nationwide online MHA rate \rightarrow \$916.50 Must enroll at MORE than half time

• 51% or higher (typically 7 Credits)

REMEMBER: ONE in-person class will grant you full eligible MHA rate

THIS DOES NOT INCLUDE COURSES FORCED ONLINE DUE TO COVID



Chapter 30 \rightarrow MGIB (Montgomery GI Bill)

GENERAL REQUIREMENTS

- Opted in to \$100 pay deductions for 12 months in IET (Initial Entry Training)
- HS Diploma or 12 prior Credits
- MUST have an honorable discharge

10 year Expiration Timeframe Phases out in 2030

Montgomery GBBill

Chapter 30 \rightarrow MGIB (Cont.)

SERVICE REQUIREMENTS

TIME IN SERVICE REQUIREMENTS

Unlike Post 9/11, MGIB is only broken into two eligibility groups based on Time in Service

- 3 or more years
- Fewer than 3 years



Chapter 30 \rightarrow MGIB (Cont.)

Chapter 31 \rightarrow Veterans Readiness and Employment

Formerly referred to as Voc Rehab

GENERAL REQUIREMENTS

- Other than Dishonorable Discharge
- 10% Disability or Higher
- Significant Employment Handicap

All Books/Fees/Supplies/Tuition covered by VR&E

Basic Eligibility \rightarrow 12 years from AD* Discharge OR Date received SC** Disability



**SC = Service-Connected

Chapter 31 \rightarrow VR&E (Cont.)

Monthly Rates for Educational Institution based on Training Time and Dependents

Training Time	No Dependents	One Dependent	Two Dependents	Each Other Dependent
Full Time (12+ Credits)	\$653.96	\$811.18	\$955.92	\$69.66
³ / ₄ Time (9-12 Credits)	\$491.38	\$609.27	\$714.69	\$53.59
¹ / ₂ Time (6-8 Credits)	\$328.78	\$407.36	\$478.83	\$35.74
1/4 Time (5 Credits or less)	\$164.37	\$203.71	\$239.42	\$17.83

Chapter 31 \rightarrow VR&E (Cont.)

SERVICE REQUIREMENTS

VR&E and Post 9/11 Eligibility

If the Vet is eligible for Post 9/11 and has at least 1 day of entitlement left, they can elect to be paid at the (higher) Post 9/11 Rate

Remember that while VR&E may pay tuition, VR&E is an EMPLOYMENT program and it is NOT an entitlement like the GI Bill



BIG Picture

Generally, Boston Veterans wishing to pursue a 4-year degree receive greater benefit from Post 9/11:

- The VA pays tuition directly
- The Veteran will receive approx. \$25K per year for books and housing.



BIG Picture

F/T Time Students Benefit from larger MHA

High COL \rightarrow Post 9/11 GI Bill usually superior Low COL \rightarrow MGIB may be superior

Other GI Bill Benefits

Forever GI Bill

Effective August 16th, 2017

Major Changes:

- 15 year time limit removed if discharged on or after January 1, 2013.
- Creation of VET-TEC (Veterans Education Through Technology Education Courses)
- 9 month STEM Extension Program
 - (STEM = Science, Technology, Engineering and Math)
- MHA based off of PHYSICAL class location
- Back entitlement for students whose school closed

Yellow Ribbon Program



Can cover out-of-state, private, or graduate tuition not covered by Post-9/11.

Vet Requirements (One of the Following):

- 100% P 9/11 eligibility
- Purple Heart recipient after 9/11/2001
- Served 60 continuous days after 9/11/2001 with service-connected discharge

Yellow Ribbon Program (Cont.)




Your school must opt in!

School Requirements:

- Must opt-in
- Not over YRP cap
- Is certified with the VA

Yellow Ribbon Program (Example 1)



Private School Tuition	\$40,000
Max VA PMT to Private School	(\$25,162)
Veteran Tuition Liability	\$14,838

With YRP, remaining tuition is split by the VA and school

Veteran Tuition Liability	\$14,838
Tuition paid by VA	(\$7,419)
Tuition paid by School	(\$7,419)
Veteran Tuition Liability	\$0

Each Institution sets their own limit on amount of students allowed and amount paid to each student

Yellow Ribbon Program (Example 2)



\$40,000
<u>(\$25,162)</u>
\$14,838

School caps YRP contribution at \$5,000 per student

Veteran Tuition Liability	\$14,838
Tuition paid by VA	(\$5,000)
Tuition paid by School	(\$5,000)
Veteran Tuition Liability	\$4,838

Non -VA Veterans Education Benefits (National Guard, State Benefits)

National Guard Tuition Waiver

The MA NG Education Assistance Program provides a 100% tuition and fee waiver for eligible servicemembers.

Eligibility:

- Actively serving NG
- Accepted to a MA state school
- <130 semester credit hours
- GPA Maintenance (IAW University)



MA Veterans In -State Tuition Waiver

Waives tuition for eligible Veterans at State Schools and Community Colleges


Eligibility:

- Honorable Discharge
- Served more than 180 Days

*** This Waiver is coordinated with School Financial Aid Office ***




STEM Extension



- Extra benefits to students in STEM
 - (Science, Technology, Engineering, and Math).
 - These fields usually requires more credit hours than other fields.
 - Reduces out of pocket costs for students training in these fields.


STEM Extension (Cont.)



Requirements for Undergrads

- Pursuing STEM degree
- Completed 60-90 credits towards degree
- Within 180 days of Post 9/11 benefit exhaustion
- Degree requires AT LEAST 120 credits

STEM Extension (Cont.)



Requirements for Undergrads

- Pursuing STEM degree
- Completed 60-90 credits towards degree
- Within 180 days of Post 9/11 benefit exhaustion
- Degree requires AT LEAST 120 credits

Cannot be used with Yellow Ribbon!

VA Work Study Program

"Earn While You Learn"

Eligibility

• ³⁄₄ or more enrollment

Earnings

- Higher of Federal or State Minimum Wage
 - Federal is \$7.25, **MA is \$13.50 (2021)**
- Up to 25 Hours/week
- Untaxed Income!

Type of Work

- Work at VA Facilities
- Veterans Resources at Institution






VA Work Study Program

VA Work Study Example:

- 25 hours per week
- 15 week semester
- <u>\$13.50 and hour</u>
 - \$5,062.50

FAFSA (Free Application for Federal Student Aid)



The FAFSA Benefits:

- Federal Loans
- Grants (Pell)
- Federal Work Study

Veterans should apply to FAFSA even if their tuition is 100% covered!



APPLY EVEN IF TUITION IS COVERED BY VA EDUCATION BENEFIT

- Pell Grants do <u>NOT</u> have to be repaid
- Max Amount in 21-22 Award year is \$6,495

SUBSIDIZED LOANS

- The government will pay some of your interest under certain conditions.
- Choose these first because they'll save you more money.

UNSUBSIDIZED LOANS

- You must pay all the interest.
- If you get an unsubsidized loan, consider making loan payments while in school and/or during your grace period to reduce your overall cost.

VUB can assist with FAFSA application

FAFSA U.S. DEPARTMENT OF EDUCATION FEDERAL STUDENT AID Vet specific tips:

Do NOT report VA Education Benefits

• NOT required to report as income

DO report other VA Benefits

- Box 44g → you <u>MUST</u> report all other
 Veterans Noneducation Benefits
- <u>THIS INCLUDES VA DISABILITY</u>

- In-Person PMT's for courses forced online due to COVID-19 extended through Dec 31, 2021
- Beginning $8/1/21 \rightarrow$ Dual Certification of Benefits
- VA will not bill you for failed classes, but WILL bill you for withdrawals if it affects your enrollment level
